PAYMENT OF TAXES

Tax decisions are delivered to mailboxes. We ask our esteemed residents to check their decisions. If an error is detected or there is a change compared to the data available to us, there will be an opportunity for correction. We draw the attention of our esteemed residents to the new way of paying taxes. In order to make the payment of the taxes even more convenient and even more transparent, in addition to the decisions, we also prepare checks for you, which can be conveniently paid at the post office in Bátka but also contain all the necessary information for a possible bank transfer.

CENSUS 2021

By the end of March 2021, 68.84 percent of the population of our village had fulfilled their census obligation. The **assisted census** will take place throughout the Slovak Republic from **May 3rd 2021 to June 13th 2021**, for six weeks, for residents who have so far been unable to fill out the electronic census questionnaire themselves or with the help of a person close to them, now they will have the opportunity at the contact point, i.e., in the municipal office, or with the help of a mobile assistant.

BIODEGRADABLE HOUSEHOLD WASTE COLLECTION

The Law no. 79/2015 on waste requires municipalities to ensure the selective collection of biodegradable household waste. An exception to this can be made if one representative of each household in the municipality declares that they are composting the biodegradable waste from their own household in their own yard or garden. In accordance with the above, we send a declaration to each household, which we ask you to sign and return to the municipal office.

IN THE LIGHT OF THE EPIDEMIOLOGICAL SITUATION, IN OUR VILLAGE ON SUNDAY, MAY 15th 2021, FROM 8:00 TO 14:00, THERE WILL BE ANOTHER OPPORTUNITY FOR THE POPULATION TO BE TESTED FOR CORONAVIRUS.
