#### FURTHER TAX AFFAIRS

We would like to draw the attention of the respected taxpayers to the fact that according to the current laws the taxpayers must submit their real estate tax and dog tax declarations by January 31st, for the tax assessment period in which the tax payment obligation for these types of taxes or one of them arose. If, during the tax assessment period, the taxpayers acquire real estate through auction or inheritance, they must submit a real estate tax declaration no later than 30 days after their tax liability has arisen.

THOSE WHO FAILED TO PAY THEIR TAXES IN THE YEARS 2017 - 2023 WILL RECEIVE PAYMENT NOTICES IN JANUARY 2024.

#### **ACTIVATION WORKS**

The current phase of the project called "Support for the maintenance of working habits" will end at the end of March 2024. The labor office will decide who can come and who can't.
